

## **BCA Virtual AGM 2021**

19 June 2021 - 14hrs (GMT + 4)

### **Information on the BCA Virtual AGM**

In line with the organisation of the virtual AGM on **19 June 2021 at 14hrs (Mauritius Time GMT + 4)**, we have come up with this document which illustrates all the steps towards the meeting.

The process of the virtual AGM will be verysimilar to the BCA virtual AGM held in December 2020 and the BWF AGM and EGM held in July 2020 and January 2021, respectively. The only difference from the last AGM will be the organization of the BCA Council's Elections during the AGM, in a virtual manner as well.

As you will remember, we provided much information to all Member Associations up to the 2020 AGM. For the 2021 AGM, we will use the same process and will provide all the required information and technical assistance so that Member Associations have access to all information and consequently voice out their opinions via the different online meetings and by email.

- ✓ The BCA **Annual Report** and the **audited accounts** will also be published on the BCA website and will be shared with all Member Associations **before 7 May 2021**.
- ✓ Member Associations and their delegates will have the opportunity to send in their questions regarding the virtual AGM. All questions and the corresponding answers will be published on the BCA website and circulated to the membership.
- ✓ Prior to the virtual AGM on 19 June 2021, BCA will organise **two webinars** (in French and English) **on the Agenda/Order Paper** of the AGM. Delegates will be able to voice out their opinion and discuss on the different items on the agenda.
- During the virtual AGM, only official delegates (voting and second delegate) will be able to take part in the meeting. As the BWF AGM, there will be less interactions and delegates will only vote when required to do so. Most of the discussions and explanations will be done prior to the AGM during video conferences and webinars that the BCA will host (see further below).

- ✓ For the online voting during the virtual AGM, BCA will work with the same technology provider, **Lumi Global**, that was used before. A test voting event will be organised with all voting delegates. The exact timing will be communicated later.
- ✓ The voting for the elections will be run by the same company. BCA will arrange for one of the **Scrutineers** to be physically present in the Lumi Global offices during the AGM.
