Team Composition for Team Event	Member Associations can either enter a maximum of one Men's Team and one Women's Team or both.
	Each Team must be composed of MINIMUM four (4) players. If your team has less than four players, you will be NOT be allowed to play the Team Event. BCA will give a maximum of 6 medals per winning team including gold, silver and bronze medalists.
	Each tie will be composed of five matches; three singles and two-level doubles. Teams winning three or more matches in any tie will be the winner. A player is not allowed to play more than 2 matches (one single and one double) per tie.
	The order of play for each match will be decided by the Referee and his decision will be final.
	All entries must be made by using the BWF Online Entry System.

Transportation	Local transportation will be provided free of charge to Participants and Officials. Both Hotels are approximately 45 minutes from the Airport and the Badminton Hall is 15 minutes from the hotels.

	Strict COVID-19 protocols will be respected for Airport transfers and daily shuttles to and from the venue.	
Accreditation	Complete the Accreditation Form attached to the prospectus at latest 6 February 2022. Also send a passport size photo of each person in your delegation to the organisers and the BCA.	
Temperature	In February, the temperature varies around 27°C during the day and at night it's around 21°C.	
Medical Services	The organisers will provide medical personnel at all times in the hall for the duration of the tournament.	
Insurance	Participants must arrange their own insurance for health, travel and property. The organisers will not responsible for any medical cost.	
BWF ID	Players cannot be entered unless they already have a BWF ID number. In case you wish to enter players, who don't have a BWF ID - number, you can now generate new BWF IDs for your players via Tournament Software.	
	If you need help to generate new BWF IDs, please contact BWF or BCA (for African Countries) well in advance of the tournament, so that the players concerned can be assigned BWF ID numbers before the closing date of the tournament	



Doping Control	Doping control in badminton, in accordance with BWF Anti-Doping Regulations, is conducted out-of-competition and in-competition with the collection of urine and/or blood samples. Athletes are responsible for any substance found in their body. Before an athlete takes any medications, they could check with their doctor, and i necessary, get a Therapeutic Use Exemption (TUE). Clothing and Advertising	Colour, design, lettering and advertising on clothing shall be regulated by BWI General Competition Regulations § 20 to 24. Any breach of these regulations will be forwarded to the BWF. In applying these regulations, the decision o the Referee shall be final.
Badminton Integrity	Section 2.4 of the BWF statutes (Code of Conduct in Relation to Betting Wagering and Irregular Match Results) relates to anti-corruption and anti- match manipulation, and this code applies to all participants in thi tournament. To protect the integrity of BWF sanctioned tournaments, participants are no allowed to bet in any way on badminton matches, respect the principle of fai play, and shall not attempt to influence the course of result of a game or a match.
	Every person has an obligation to report to BWF any approaches by anyone to gather inside information or to change the outcome of matches. For more information, please visit the website <u>https://corporate.bwfbadminton.com/integrity/anti-match-fixing-overview/</u>
Conditions	The tournament will be played on knock-out system and in full accordance wit the General Competition Regulations of the BWF and the instructions of Badminton Confederation Africa.
	Competitors must be prepared to play at the times determined for the event for which they have entered. All prizes will be distributed during the officia prize giving ceremony after the respective finals. Players shall not plan their departure before the prize giving ceremony; th organisers will not award medals or prize money before the finals.



	According to the BWF General Competition Regulations, there is no world ranking points for an international tournament with less than 8 entries in (MS, WS, MD, WD, XD) at the time of the draw.
	In such a case, the tournament maybe cancelled, and the organisers will not take any responsibility for any arrangements that may have been already made.
	Compliance with General Competition Regulations Clause 7.9
	GCR 7.9: "In making or authorising entries, the Member concerned is reconfirming its acceptance, and acceptance by the Players being entered, of the BWF's regulations and Disciplinary processes."
	Visitors are permitted to enter the country, by land or air (Entebbe International airport) with a negative PCR COVID-19 test taken no more than 72 hours before boarding aircraft in-bound to Uganda.
Covid-19 Restrictions (Important)	The Government of Uganda requires that all departing passengers present a negative PCR COVID-19 test taken not more than 72 hours before departure. This requirement is mandatory for all departing passengers out of Uganda even if the destination country does not require it.
	PCR test will be done on arrival for all passengers with the cost USD 30, Registration is compulsory before arrival in Uganda - click here: <u>https://arrivals.healthdesk.go.ug/home/</u>
	Another test will be done prior departure from Uganda, as the end of the tournament – at a cost of USD 50.
	For a full list of accredited laboratories and approved sample collection points, please visit the Uganda Ministry of Health's <u>website</u> .
	Travelers are expected to cover all costs associated with their COVID-19 test prior to departure, from their country of origin, on arrival and prior departure from Uganda. In case of any positive case, it is strongly recommended that all participants take a medical and travel insurance to cover any unexpected medical expenses.
	In-bound travelers will be subject to temperature and health screening upon arrival.
	Any arriving passengers who exhibit signs or symptoms of an infectious disease will be transported to an isolation centre for a COVID-19 test where they must remain, at their own cost, until the results of the test are received. Travelers who test positive will be taken to a Ministry of Health facility for treatment or given the option to be repatriated (for foreigners), at their own cost.

	A nationwide curfew is enforced from 7pm to 6am. Note that arriving and departing airline passengers will be exempt curfew restrictions when their flights take place during quarantine hours.
	Quarantine is not required for arriving foreign nationals who have a negative PCR COVID-19 test result done by an accredited laboratory in the country of origin, unless the person exhibits signs or symptoms of an infectious disease.
