Doping Control	Doping control in badminton, in accordance with BWF Anti-Doping Regulations, is conducted out-of-competition and in-competition with the collection of urine and/or blood samples. Athletes are responsible for any substance found in their body. Before an athlete takes any medications, they could check with their doctor, and if necessary, get a Therapeutic Use Exemption (TUE). Clothing and Advertising	Colour, design, lettering and advertising on clothing shall be regulated by BWF General Competition Regulations § 20 to 24. Any breach of these regulations will be forwarded to the BWF. In applying these regulations, the decision of the Referee shall be final.
Badminton Integrity	Section 2.4 of the BWF statutes (Code of Conduct in Relation to Betting, Wagering and Irregular Match Results) relates to anti-corruption and antimatch manipulation, and this code applies to all participants in this tournament.
	To protect the integrity of BWF sanctioned tournaments, participants are not allowed to bet in any way on badminton matches, respect the principle of fair play, and shall not attempt to influence the course of result of a game or a match.
	Every person has an obligation to report to BWF any approaches by anyone to gather inside information or to change the outcome of matches.

Conditions	The tournament will be played on knock-out system and in full accordance with the General Competition Regulations of the BWF and the instructions of Badminton Confederation Africa. Competitors must be prepared to play at the times determined for the events for which they have entered. All prizes (including prize money) will be distributed during the official prize giving ceremony after the finals. Players shall not plan their departure before the prize giving ceremony; the organisers will not award medals or prize money before the finals. According to the BWF General Competition Regulations, there is no world ranking points for an international tournament with less than 8 entries in (MS, WS, MD, WD, XD). In such a case, the tournament maybe cancelled, and the organisers will not take any responsibility for any arrangements that may have been already made. Compliance with General Competition Regulations Clause 7.9 GCR 7.9: "In making or authorizing entries, the Member concerned is reconfirming its acceptance, and acceptance by the Players being entered, of the BWF's regulations and Disciplinary processes."
Covid-19 Restrictions (Important)	Negative PCR COVID-19 test result is required before entering Benin with the test having been carried out less than 5 days before arrival or, if you want to use an anti-gen test, a negative result less than 72h prior to arrival. No PCR test will be performed upon arrival. Travelers are expected to cover all costs associated with their COVID-19 test prior to departure from Benin. In case of any positive case, it is strongly recommended that all participants take a medical and travel insurance to cover any unexpected medical expenses.
