4. COUNCIL PROPOSAL

A) Due to the reorganization of the BCA management structure, necessitated by the growth and the demand of the BCA to have a global professional outlook and to better serve its members, the BCA Council proposes to replace the term Secretary General, in the constitution with Chief Executive Officer to align with the new approved BCA Administrative structure.

Instead of a Secretary General, the BCA recruited a **Chief Executive Officer** (CEO) and the **Head Operating Officer** (HOO) from the list of candidates who applied for the post of SG.

This change is in line with BCA's vision to **professionalize the organization** and the resulting **administrative needs**.

The **CEO** will occupy a more **executive** position with a focus on **strategic** initiatives, **marketing** and **business** strategy, **governance** department, **partnerships** and **chief of staff**

The CEO will also be responsible for all current constitutional functions of the Secretary General, including calling meetings, matters relating to the GA, being the Chief of Staff, the supervision and daily running duties of the prospective foundation and any other cognit duty.

B) To facilitate the registration of BCA's office in Mauritius and as per the BCA and BWF Council approval, the BCA Council proposes the inclusion of a transitional clause of the Foundation Charter in the BCA Constitution.

Rationale

For some time now the BCA has been trying to register its office in Mauritius but due to the nature of our organization as a confederation the process has had some challenges necessitating the enactment of laws to facilitate the registration.

As this process has to go through the Mauritian Parliament, it has taken quite some time not forgetting the Covid period which delayed the process even further.

After close consultations with the BWF and legal advice from our lawyers in Mauritius a decision was reached to register the BCA as a foundation under the Foundations Act of the Mauritian Republic pending the enactment of the necessary laws to register BCA as a confederation.

It's the proposal of council to include the foundation Charter <u>Linked here</u> in the constitution as a transitional clause to facilitate the registration of the BCA in Mauritius. The transitional clause will automatically cease to exist when the legal framework in the Republic of Mauritius allows the confederation to be registered and become autonomous.
