Doping Control	Doping control in badminton, in accordance with BWF Anti-Doping Regulations, is conducted out-of-competition and in-competition with the collection of urine and/or blood samples. Athletes are responsible for any substance found in their body. Before an athlete takes any medications, they could check with their doctor, and if necessary, get a Therapeutic Use Exemption (TUE). Clothing and Advertising	Colour, design, lettering and advertising on clothing shall be regulated by BWI General Competition Regulations § 20 to 24. Any breach of these regulations will be forwarded to the BWF. In applying these regulations, the decision of the Referee shall be final.
Conditions	The tournament will be played on knock-out system and in full accordance with the General Competition Regulations of the BWF and the instructions of Badminton Confederation Africa.
	Competitors must be prepared to play at the times determined for the events for which they have entered. All prizes will be distributed during the official prize giving ceremony after the finals.
	Players shall not plan their departure before the prize giving ceremony; the organisers will not award medals or prize money until <u>ALL</u> finals are over.
	According to the BWF General Competition Regulations, there is no world ranking points for an international tournament with less than 8 entries in (MS
	WS, MD, WD, XD). In such a case, the tournament maybe cancelled, and the organisers will not take any responsibility for any arrangements that may have been already made.

Badminton Integrity	Section 2.4 of the BWF Statutes (Code on The Prevention of The Manipulation of Competitions) relates to anti-corruption and anti-match manipulation, and this code applies to all participants at this tournament. To protect the integrity of BWF sanctioned tournaments, participants are not allowed to bet in any way on badminton matches, shall respect the principle of fair play, and shall not attempt to influence the course or result of a game or match. Every person has an obligation to report to the BWF any approaches by anyone to gather inside information or to change the outcome of a match(es).
