Accommodation	The Neighbourgood Hotel* (https://neighbourgood.pixieset.com/neighbourgoodnewlands/)  Price (Half board – Bed & Breakfast)  Single Room: ZAR 1500 / Person / Night (approx. USD 80)  Double Room: ZAR 800 / Person / Night (approx. USD 45)  * The hotel is approximately 500m from Cavendish Square which is a shopping mall with restaurants for meals (also available at the hall and around for less than \$10/meal).			
Transportation	Transportation to and from the venue will be provided free of charge to Participants and Officials for the official hotel only. The hotel is around 17Kn from the airport (20 minutes' drive) and less than 10 minutes' drive from the hall.			
Temperature	In early December, the temperature varies around 27°C during the day and at night it's around 17°C.

BWF ID	Players cannot be entered unless they already have a BWF ID number. In case you wish to enter players, who don't have a BWF ID - number, you can now generate new BWF IDs for your players via Tournament Software.
	If you need help to generate new BWF IDs, please contact BWF or BCA (for African Countries) well in advance of the tournament, so that the players concerned can be assigned BWF ID numbers before the closing date of the tournament.
Doping Control	Doping control in badminton, in accordance with BWF Anti-Doping Regulations, is conducted out-of-competition and in-competition with the collection of urine and/or blood samples.
	Athletes are responsible for any substance found in their body. Before an athlete takes any medications, they could check with their doctor, and if necessary, get a Therapeutic Use Exemption (TUE).

	According to the BWF General Competition Regulations, there is no world ranking points for an international tournament with less than 8 entries in (MS,
	WS, MD, WD, XD). In such a case, the tournament maybe cancelled, and the organisers will not take any responsibility for any arrangements that may have been already made.
	Compliance with General Competition Regulations Clause 7.9 GCR 7.9: "In making or authorizing entries, the Member concerned is reconfirming its acceptance, and acceptance by the Players being entered, of the BWF's regulations and Disciplinary processes."
