USD 45) * The hotel is approximately 500m from Cavendish Square which is a shopping mall with restaurants for meals (also available at the hall and around for less than \$10/meal).			
Transportation	Transportation to and from the venue will be provided free of charge to Participants and Officials for the official hotel only. The hotel is around 17Km from the airport (20 minutes' drive) and less than 10 minutes' drive from the hall.			
Temperature	In early December, the temperature varies around 27°C during the day and at night it's around 17°C.

Doping Control	Doping control in badminton, in accordance with BWF Anti-Doping Regulations, is conducted out-of-competition and in-competition with the collection of urine and/or blood samples.			
	Athletes are responsible for any substance found in their body. Before an athlete takes any medications, they could check with their doctor, and if necessary, get a Therapeutic Use Exemption (TUE).

	WS, MD, WD, XD). In such a case, the tournament maybe cancelled, and the organisers will not take any responsibility for any arrangements that may have been already made.
