ACTIVITIES

Introduction

In the wake of unprecedented challenges posed by the global COVID-19 pandemic, the Badminton Confederation Africa (BCA) persevered with resilience and determination throughout the year 2023. Building upon the successes and lessons learned from the previous year, BCA continued its mission to advance badminton across the African continent, focusing on key areas such as player development, capacity building, coach education, and grassroots engagement under the Shuttle Time program.

Player Development Program Activities:

One of the cornerstones of BCA's activities in 2023 was the Player Development Program, which saw a series of impactful training camps aimed at honing the skills and capabilities of athletes across Africa. Notable events included the Players Training Camp in Namibia, the U17 Training Camp in Region 3, all of which played a pivotal role in preparing athletes for the Road to Paris 2024 and other international competitions. To promote inclusivity in the sport the BCA was at the fore front of organizing notable events for Para Badminton like the Para Players Training Camp, and the Africa Para Badminton Championship, all held in Kampala, Uganda. These activities provided a platform for para badminton athletes to showcase their skills and compete at a high level, contributing to the overall growth of Para Badminton in Africa.

BCA's Capacity Building Initiatives:

In parallel, BCA's commitment to Capacity Building of its Member Associations remained unwavering, with a range of initiatives designed to enhance the knowledge and expertise of badminton stakeholders. From conducting accreditation workshops and assessments

were carried out in Benoni, South Africa. Workshops for umpires were also in Hammamet, Tunisia and Harare, Zimbabwe.

BCA's Coach Education Program Activities:

The Coach Education program remained a focal point of BCA's efforts in 2023, offering various courses and webinars aimed at empowering coaches with the latest techniques and best practices. BCA organized several coach education courses, including the BWF Coach Education Level 1 courses in various locations, such as Algiers, Algeria, and Cotonou, Benin. These courses attracted participants from diverse backgrounds, contributing to the growth of qualified coaches and the overall improvement of coaching standards within the region.

Shuttle Time 2023 Activities:

The Shuttle Time program continued to play a vital role in introducing badminton to children and promoting the sport at the grassroots level. In 2023, the BCA organized courses, workshops, and events aimed at teachers, Shuttle Time tutors, and young players. Activities like the Shuttle Time Tutors Course, Shuttle Time Teachers Course, and Shuttle Time Animation with children furthered BCA's mission of fostering a love for badminton among the youth and building a strong foundation for future generations of players. As we reflect on the dynamic calendar of events and activities in 2023, this annual report serves as a testament to BCA's ongoing commitment to excellence, inclusivity, and innovation in advancing badminton across Africa. Each milestone achieved and initiative undertaken underscores the collective effort and dedication of BCA, its Member Associations, and the badminton community at large, setting the stage for a bright and promising future for the sport.

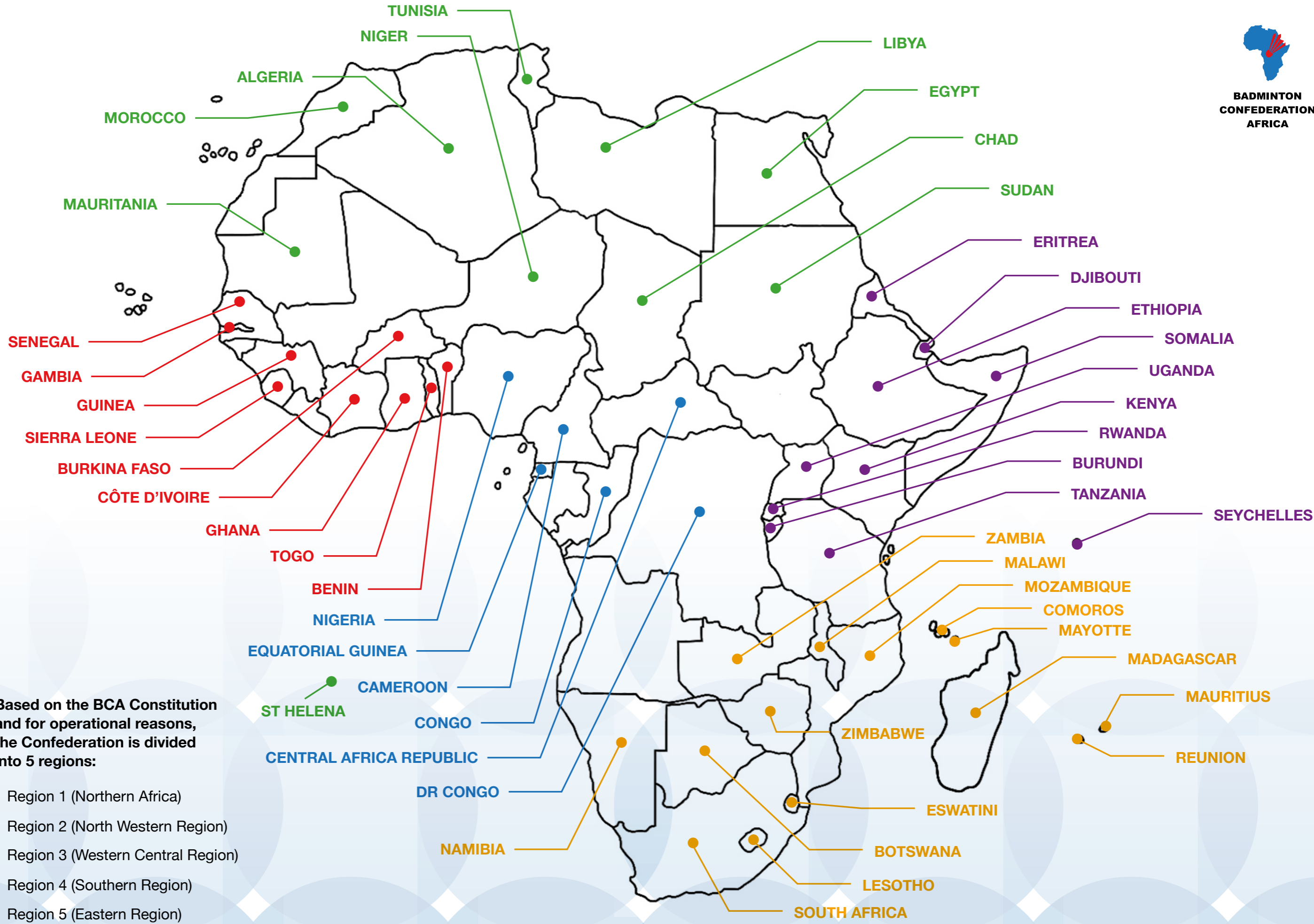

GOVERNANCE

Introduction

The year 2023 marked significant milestones for the Badminton Confederation Africa (BCA), highlighted by key governance changes and strategic initiatives aimed at enhancing the organisation's effectiveness and impact within the African badminton community.

The transition from the traditional Secretary General role to the CEO position reflects BCA's evolution towards professionalizing its operations and enhancing accountability. The CEO's responsibilities encompass strategic planning, organisational oversight, and stakeholder engagement, aligning with BCA's long-term vision and objectives.

Election of Council Members

One of the pivotal events of 2023 was the election of new council members during the BCA Annual General Meeting (AGM) held in Kuala Lumpur, Malaysia. The election process saw the election of new members in BCA Council, notably the position of the Deputy President and Treasurer, reflecting BCA's commitment to democratic governance and transparent leadership transitions.

Launching of BCA Strategic Plan 2022-2028

A pivotal moment in BCA's journey in 2023 was the launch of the Strategic Plan for the period 2022-2028. This comprehensive plan outlines BCA's strategic priorities, including but not limited to:

- Enhancing player development programs and talent identification initiatives.
- Strengthening governance structures and promoting transparency and integrity.
- Expanding grassroots initiatives such as the Shuttle Time program to promote inclusivity.
- Fostering partnerships with stakeholders, including member associations, sponsors, and the wider badminton community.
- Promoting gender equity and diversity within the sport through targeted initiatives and programs.
- Leveraging technology and digital platforms for enhanced communication, marketing, and fan engagement.
- The Strategic Plan serves as a roadmap for guiding BCA's activities and initiatives, ensuring alignment with its mission of promoting and developing badminton across Africa.

Mr. Kingston Mulenga from Zambia was elected as the Deputy President, bringing a wealth of experience and a vision for inclusive development across member associations. Similarly, Mr. Mpiwa Bosenogile from Botswana assumed the role of Treasurer, bringing expertise in financial administration and a focus on fostering partnerships for sustainable growth of the BCA.

The election of eleven council members, representing diverse backgrounds and expertise, further strengthened BCA's governance framework, ensuring a robust leadership team to steer the organisation forward.

Restructuring of BCA Administration

In line with strategic objectives and operational efficiency, BCA underwent a restructuring of its administration in 2023. This restructuring included the appointment of a Chief Executive Officer (CEO) Mr. Jeff Shigoli and Head of Operations, Mrs. Rajae Rochdy with the CEO assuming leadership of the BCA Secretariat.

In Conclusion, the governance section of the 2023 Annual Report reflects BCA's commitment to robust governance practices, evidenced by the election of new council members, restructuring of the administration with the appointment of a CEO, and the launch of a strategic plan that sets a clear roadmap for the organisation's future endeavors. OUT OF AFRICA EVENTS

1. TotalEnergies BWF Sudirman Cup Finals 2023 was held in China and Egypt qualified for Africa.
2. For the TotalEnergies BWF World Championships in Denmark, Nigerian Anuoluwapo Opeyori, Mauritian Julien Paul and Egyptians Adham H. Elgamal and Doha Hany played in their Singles, South Africans Jarred Elliot and Robert Summers, Amy Ackerman and Deidre Laurens played in their Doubles along with Mauritian pair Lorna Bodha and Kobita Dookhee, and finally, pair

Adham H. Elgamal and Doha Hany played in Mixed Doubles. Unfortunately, none of them were able to move to the second round.

3. The BWF World Junior Championships, in the US, saw the participation of the junior Ghanaian team comprising of boys Nathaniel ABAKAH, Leslie Adote Nii ADDO, Andy AMOFA, Michael BOTWE, Ebenezer KORAMPONG and Elvis OSEI. The girls team comprised of Moslena Ama Korama ADU, Eliana Owusu AFRIYIE, Gloria NYAME, Rachael QUARCOO, Shelia Abena Bofoa TAYLOR and Cindy Etornam TORNYENYOR.
4. The Chengdu 2021 FISU World University Games, played in August 2023, also saw the participation of **Kenyan Fabian Derrick ODHIAMBO**,

Motunrayo ABIOLA, Simeon Abiodun AKINSOLA, Segun Obasanjo IDOWU, Aminat Oluwafunke ILORI, Miu UCHIDA and Mujittapha UMAR from Nigeria, Jarred ELLIOT and Robert SUMMERS from South Africa, Amos MUYANJA, Kenneth Comfort MWAMBU, Kruthum NALUMANSI, Augustus OWINYI, Assumpta OWOMUGISHA, Abdulswaburuh SSEMPIRI and Husina KOBUGABE from Uganda, Mutale MUKUKA and Malama MUSONDA from Zambia

5. South Africans Johan CROUKAMP, Lynn FRY and Stewart OVERKOTT BROWN were the only players from Africa to participate in the JEONJU BWF World Senior Championships 2023.

8. However, the BCA Council remains concerned about the limited capacity of member associations to step forward and host additional Para badminton internationals in Africa.

BCA SUPPORT TO EVENTS & OTHERS

9. Though the cut in budgets and income, the BCA is still committed to support organisers of international tournaments in Africa. Apart from the organisation grant of \$550, BCA supports with a photography grant of \$150 and the tournament shuttlecocks. In addition, Technical Officials like Referees and umpires are also often appointed by the BCA.
10. BCA directly supported the participation of MAs in its 3 major Championships in 2023. A colossal amount of **\$ 58,370** was paid as grant to participating countries in 2023.
11. In 2023, Uganda, Reunion Island, Cameroon, Nigeria and Egypt managed to sustain their International tournaments with a minimum of \$10,000 prize money. The Uganda Badminton Association was also able to add a second \$10,000 prize money tournament making it the only country in Africa to have at least 2 tournaments at that level of prize money.



PARA BADMINTON EVENTS

6. The Africa Para Badminton Championship took place in Uganda, just after the Uganda Para Badminton International (6th edition). With BWF and BCA support, 11 African countries were present in Kampala.
7. Uganda Para Badminton International was another great success from Uganda Badminton Association by participation of 11 countries from the whole world.





TECHNICAL OFFICIALS

1. In February 2023, BCA conducted its Accreditation level assessment in South Africa, alongside the All Africa Senior Championships. 13 Participants from 10 countries were supported by BCA and the participants were allocated duties during the 2 championships, the Team Event and the Individual Event.
2. BCA has been able to appoint Referee Assessors in some tournaments in order to work on improving the current BCA Referees pool and, as well, work on making sure the referees appointed as Deputy Referees are mentored and followed as closely as possible.
3. The BCA TOC held regular meetings online and the BCA TOs database was updated. Decision making, at the Commission level, is democratic and inclusive. The Commission has also been communicating with all BCA TOs via email, WhatsApp and other platforms.
4. The BWF has designed and published quite a few resources, including manuals for Umpires, Referees, Line Judges and organisers. There are also several videos online for TOs. All these resources are available in English and French and are available on the BWF Website.
5. BCA has successfully conducted Umpires Workshops prior to each of its major events in order to better prepare the TOs officiating during the tournaments. This has resulted in an improved level of umpiring but there are still

some grounds that can be covered to ensure a more standardised level of umpiring. MAs can be encouraged to collaborate by sending/hosting the TOs, especially if they are close neighbours and the TOs can get exposure to more tournaments.

6. The following is a consolidated table of all African BWF Technical Officials as at end of 2023 (see table below).
7. In 2021, the BWF introduced a unique category for their umpires – the BWF Umpire. Previously, it used to be an entry level with the BWF Accredited Umpire and a second level, the BWF Certificated Umpire. This change has made it more difficult for our umpires to bridge the gap and reach the BWF level.
8. The BCA TOC has identified a number of BCA Certificated Umpires who may be nominated for BWF Assessments in 2024. Based on the criteria set out by the Commission, these umpires will be nominated and trained before their assessments to BWF Umpire in 2024. They are from Algeria, Nigeria, Tunisia and Zambia.

9. Depending on availability, these selected Umpires will be sent to tournaments out of Africa for exposure. To assist our TOs workforce, BCA is continuing to collaborate with other Continental Confederations, namely: Badminton Europe, Badminton Asia Confederation and Badminton Oceania. This collaboration enables our Umpires to gain vital experience at higher level tournaments before their BWF Assessment.
10. As BCA has only 2 BWF Referees, BCA is planning for the next few years to increase the number of referees and train them to be qualified to the BWF level. Some BCA Referees have been identified and have also passed their assessment having undergone tournaments under the Referee Assessors. These Referees will be nominated and trained in 2024 and 2025 in order to better prepare them for BWF Accredited Referee Assessment which will take place in 2025. In this regard, BWF has already set certain measures in place in 2023 to be able to appoint these Referees to major BWF tournaments. All of them have been successfully appointed as Deputy Referees in several Super Series tournaments.

DEVELOPMENT REPORT 2023



Coach Education

1. Year to year as the sport is growing well in the continent, BCA development activities are increasing. BCA now through its strategic plan is given more opportunities to MAs to train more technical resources and ensure they receive good training. It has advised the MAs to get support from their NOC through the Olympic Solidarity.
2. In 2023, six (6) BWF Level 1. 74 coaches were trained. 57 out of 74 are qualified BWF Coach Level 1.

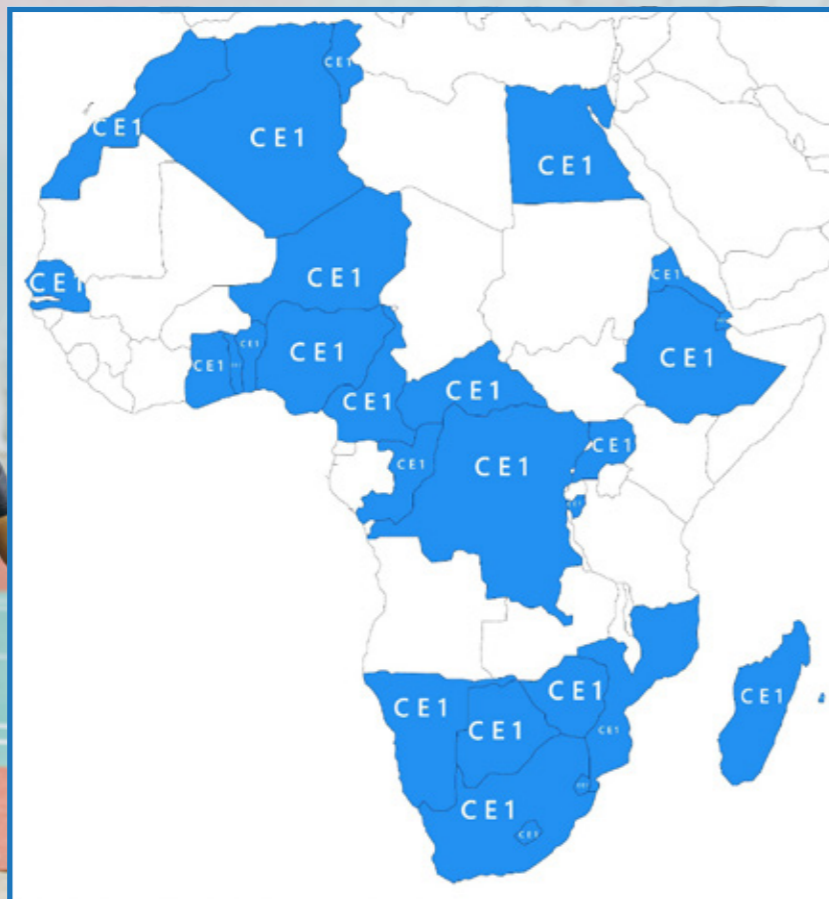
8. The course held in Benin was sponsored by the Olympic Solidarity Benin NOC.

9. In total Africa has 94 qualified BWF Level 2 Coaches.

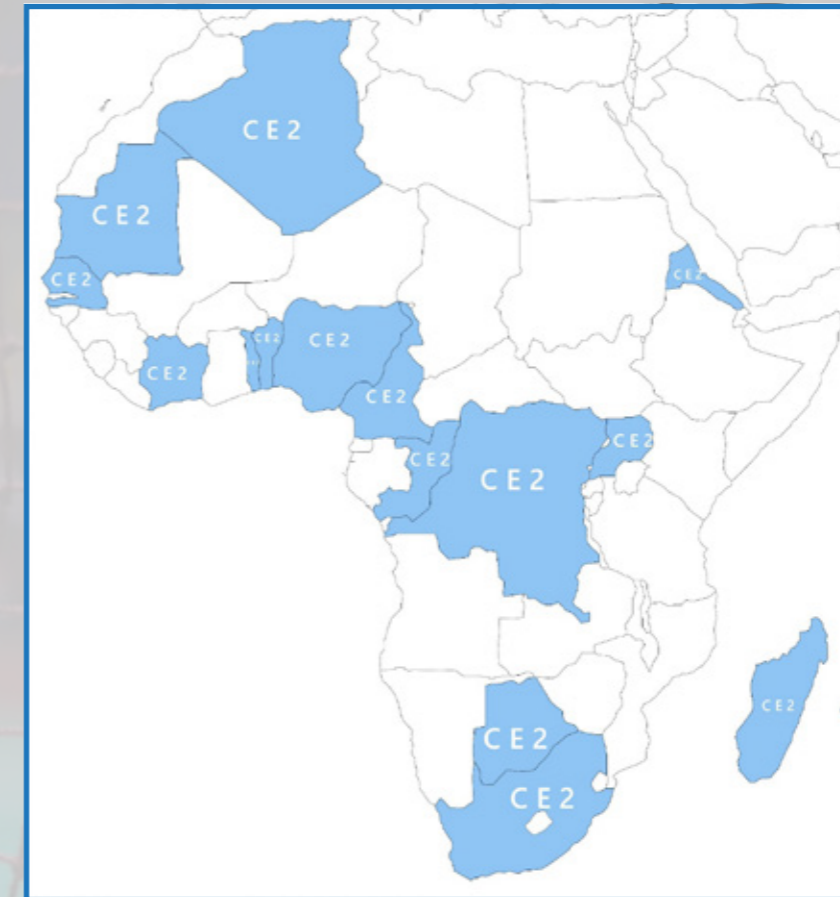
10. BCA Mentoring programme is running well. Our BWF Expert Mr Bernadin Bokpè and Dr Ahmed Reda both Development Managers are training by assisting Mr Dajee Annirao to learn and get ready for the BWF Level 2 Tutors Assessment.

11. Overall, 33 countries have been trained to BWF Coach Education Level 1 and 17 countries to BWF Coach Education Level 2.

15. For the second edition of BCA International Coaching Scholarship (ICS), Eight (8) coaches were selected and seven (7) reached the academies in Malaysia, Dubai and Denmark. Selected coaches are from Cameroon, Eritrea, Senegal, South Africa, Tunisia and Zambia.

16. BCA supported coaches to attend training camp organised precluding the AAU15 Championships. Nine (9) Coaches from Algeria, Botswana, Cote d'Ivoire, Egypt, Mauritius, South Africa, Tunisia, Zimbabwe attended the training camp.





Shuttle Time

17. The programme is still running well in Africa and still our main grassroots programme to develop badminton game through the continent. Namibia joined the programme. The total of countries developing the programme is now 37 in Africa.

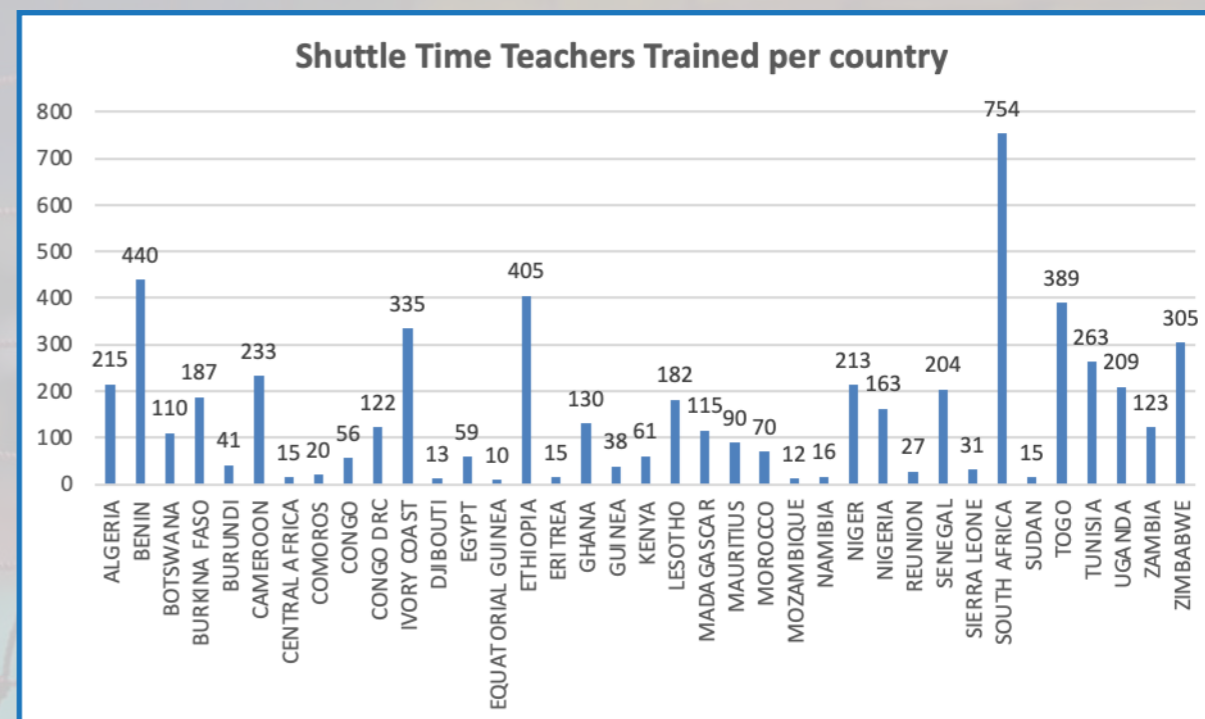

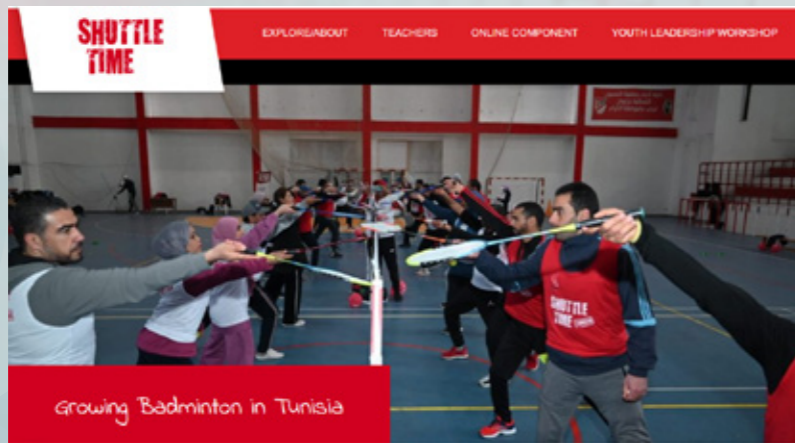

Through the good relationship between MAs, they are assisting each other. As example Senegal and Gambia have a partnership where Gambia teachers are invited to participate in the Shuttle Time Teachers Course in Senegal; Tunisia helped Libya to receive their equipment through Tunisia Badminton Federation; Djibouti facilitate the process to Somalia Badminton Association to receive their equipment through Djibouti Badminton Federation; South Africa assisted Zimbabwe and Namibia to receive their equipment through South Africa; Cameroon assisted Equatorial Guinea to receive their equipment through Cameroon Badminton Federation.

Players Development

In 2023, the Olympic Race to the Paris Olympic Games 2024 began.

The players in the Road to Paris program were supported to participate in international tournaments and training camps, starting with the Uganda International Challenge, followed by the Mauritius International and Reunion International tournaments, which were both the first African tournaments counting towards the Olympic Race. The Lagos International Classics, a Grade 3 - International Challenge, followed immediately after the World Championship, where players in the program continued to collect points in the Olympic Race. Players from five countries (Algeria, Egypt, Mauritius, South Africa, and Nigeria) in Africa are part of the Road to Paris program.

Para badminton athletes also benefited from scholarships to participate in the Bahrain Para Badminton International (BWF Level 2) and the Dubai Para Badminton International (Level 2).

Para badminton players were also granted scholarships for training, classification, and participation in the Uganda Para Badminton International and the Africa Para Badminton Championship in Uganda.

BCA organized a training camp prior to the AAU15 Championships, with 65 players from eight countries (Algeria, Botswana, Egypt, Cote d'Ivoire, Mauritius, South Africa, Tunisia, and Zimbabwe) participating in the training camp.

A new election was held for the Athletes Commission Representative. Mrs. Deidre Laurens, Mr. Tejraj Pultoo, and Mr. Adham Hatem El Gamal were elected for the upcoming four-year mandate. Mrs. Deidre Laurens serves as the Chair of the Commission.



Capacity Building

In 2023, BCA developed numerous online activities to guide and enhance its stakeholders and continue building a strong badminton family in Africa. Various activities were held, and support was given to different resource persons, including coaches, administrators, technical officials, and others.

The online activities have shown that it is an efficient way to deliver courses. In 2023, BCA organized 50% of its courses with the aim of building and enhancing the capacity of member associations through online courses.

A Para Badminton online webinar provided an opportunity for participants from 15 countries across the continent to attend courses on classification and coaching delivered by BWF experts.

An Events Management Course (Level 2) was held in Egypt with participants from five countries (Egypt, Mauritius, South Africa, Uganda, and Zambia). This joint BWF/BCA high-level course included senior observers from three countries (Egypt, Nigeria, and Uganda) who were able to share their insights on tournament organisation. The course was organized to strengthen the capacity of member associations

already organizing BWF sanctioned tournaments, guiding them on how to improve the general level of their tournaments.

Following that course, IPC/BWF/BCA organized activities in Egypt for para-athletes, coaches, and administrators. This course provided an opportunity to bring together representatives of the National Paralympic Committee and National Federation to attend a National Administration course on Para Badminton. Representatives from Burkina Faso, Egypt, Ethiopia, Libya, Namibia, Nigeria, South Africa, Sudan, Somalia, and Tunisia left Egypt with information to work on strategic plans to develop Para Badminton in their countries.

2023 also marked the empowerment of women involved in badminton with the launch of the BCA MA Women's Representative programme. In many activities, women are underrepresented, while the IOC and BWF strongly advise a presence of 40% women participation. It is in this regard that BCA launched a programme to empower women by creating a network of women who proudly represent their National Federation and serve as voices to spread information about BCA activities.



To end the year, BWF/BCA also held back-to-back Events Management Course (Level 1) and National Administration Course in Senegal; the latter will host the Youth Olympic Games in 2026. Senegal being a young active Member Association, BWF/BCA has initiated collaborations across several projects

all geared towards YOG 26 and enabling the MA towards holding that major event successfully. In this effort, 2 new projects, spearheaded in Africa and piloted by BWF/BCA, will take place in August 2024 which will see AirBadminton Continental Junior Championships being held for the first time.

Para Badminton

A series of online webinars mentioned earlier in the capacity building part for coaches and national classifiers in Africa delivered by BWF experts represent a significant milestone in the journey towards fostering inclusivity and excellence in Para Badminton.

The 5th Para Badminton Workshop in Uganda prior to Uganda Para Badminton International and Africa Para Badminton Championships represented a shining example of how sports can serve as a catalyst for social change and empowerment. By providing coaches with specialized training and Para athletes with opportunities for classification and competition.

More than 13 coaches and 11 para players from Benin, Cameroon, Egypt, Mozambique, Nigeria, Senegal, Togo and Tunisia were supported in 5th Para Badminton Workshop.

Egypt is the second country after Uganda that is planning to host a Para Badminton International in the African landscape. In this regards, BWF Hosted Advanced Para Badminton workshop in Egypt with IPC and BCA collaboration including Administration course, Advanced Coaching course and players

training camp with participation of 15 countries to prepare Egypt Badminton Federation for the tournament. The candidates represented their MAs and NPCs, and the courses were delivered by BWF and BCA experts.

The exceptional performances of Para Badminton players in 2023 are a testament to the power of passion, perseverance, and possibility.

Mariam Eniola (SL3) from Nigeria made extraordinary achievements by winning 3 gold medals in Uganda Para Badminton International, Africa Para Badminton Championships, and Dubai Para Badminton International, while Shaimaa Samy (WH2) from Egypt won gold medal in Africa Para Badminton Championships and Silver medal in Uganda Para Badminton International.

Jeremiah Nnanna (SL4) from Nigeria won gold medal in Africa Para Badminton Championships and bronze medal in Uganda Para Badminton international. African para-athletes are improving their BWF Para Badminton World Ranking in all categories, and we can notice more and more African flags among the top 20 world best para badminton athletes.



AirBadminton

In 2023, The promotion of AirBadminton in Africa in 2023 marked a significant milestone in the diversification and expansion of the sport with the programming of Airbadminton competition during the African Beach Games in Tunisia which was qualifying for the ANOC World Beach Games 2023 planned in Bali. Unfortunately, those games were cancelled at the last minutes by the Indonesian Olympic Committee.

The simultaneous organisation of AirBadminton initiatives alongside development activities (ex. Coach education, Shuttle Time courses) in Tunisia, Guinea, and Eritrea in 2023 underscores the transformative potential of wide spreading of this new sport.

Tunisia hosted African Beach Games was organized in Hammamet from 27-30 June 2023 where 8 countries (Algeria, Benin, Equatorial Guinea, Mauritius, Nigeria, South Africa, Tunisia, and Zambia)

has participated. Airbadminton received 17 intentions of participation from African NOC to participate in the Games. Prior to the games, AirBadminton Umpires Workshop was organized prior the African Beach Games in Tunisia delivered by BWF expert.

To Celebrate the World Badminton Day, BCA organized an entertaining day with many activities including AirBadminton during the Africa Para Badminton Championship. Some Para Badminton, Special Olympics and Deaf players discovered the game for the first time.

AirBadminton is a good way for youth player to discover different way to play. A successful tournament was organized during the All Africa U15 Championships in December in Zimbabwe with participation of 7 countries (Botswana, Egypt, Ivory Coast, Mauritius, South Africa, Tunisia, Zimbabwe).



Gender Equity

In line with IOC and BWF guidelines, BCA Gender Equity Commission is still working year to year to improve women participation in badminton activities. Below you can see the gender equity achievement in 2023.

2023 is for one more year a successful one regarding gender equity. With BCA and MAs' efforts, BCA reached the average of **36,21%** of women participation in all the activities. However, women participation at national level is still low in some region of our continent. BCA and BWF are expecting MAs to continue to include more women in their activities and empower them.

The areas where the 30% of women participation is achieved are mostly activities lead by BCA or sponsored by BWF. The new Programme dedicated to women called " MAs Women Representative Meeting " is an opportunity to help reaching more women and bring more women to badminton in the future. The first edition of MAs Women Representative Meeting was a great session with 14 women from 14 MAs who was nominated to represent their national federation. This meeting is an achievement of Gender Equity Commission in 2023. However, more gender equity activities are coming in 2024.

ADMINISTRATION AND REMUNERATION

The year 2023 marked a significant evolution in the administrative landscape of the Badminton Confederation of Africa (BCA), reflecting our commitment to continuous improvement and strategic development. Building upon the achievements and lessons learned in 2022, the BCA embarked on transformative changes aimed at enhancing efficiency, governance, and organisational structure.

One of the key highlights of 2023 was the implementation of a new administrative framework, culminating in the introduction of the Chief Executive Officer (CEO) and Head of Operation (HOO) positions. This restructuring, initiated after thoughtful consultation and resolution by the BCA council, marks a pivotal shift towards a more streamlined and dynamic leadership structure. The CEO and HOO roles were designed to replace the traditional office of the Secretary General, aligning with global best practices in sports administration.

Furthermore, the BCA made significant progress in its journey towards formal registration as a foundation in Mauritius under the Mauritius Foundation Act, with the Badminton World Federation (BWF) as the founder. This process, which began earlier, reached a crucial stage in 2023, showcasing our commitment to transparent governance and adherence to regulatory standards. The anticipated benefits of this registration include tax exemptions, facilitation of import processes, and enhanced administrative support for BCA activities and events.

In parallel with these structural advancements, the BCA also prioritized staff welfare and professional development. The recruitment of key personnel underscores our focus on building a capable and motivated team to drive the BCA's mission forward.

Looking ahead, the BCA remains steadfast in its commitment to excellence in administration, governance, and organisational effectiveness. As we navigate the challenges and opportunities of the coming years, we are confident that our strategic initiatives and commitment to best practices will continue to strengthen the foundation of the BCA and contribute to the growth and success of badminton in Africa.

KEY RESPONSIBILITIES

Staff

1. In 2022, BCA recruited Faadil SAYED for the post of Events & IT Manager as per CCHR plan. Plans are underway for the recruitment of a Communication & Administration Officer.
2. After more than 9 years of service to the Confederation, our long serving Secretary General Mr. S. Edoe resigned and joined the BWF as a Head of Development Projects. His contribution to the BCA was instrumental throughout the past years.
3. After consultation, the BCA council resolved to restructure its administrative organogram by hiring a Chief Executive Officer (CEO) and Head of Operation (HOO) to replace the office of the Secretary General. The anticipated staff handbook, meant to delineate all staff policies and regulations, was approved and adopted by the Council.

BCA Office Registration

1. The registration process of the BCA Office in Mauritius is still ongoing. The BWF through its council approved the formation of the BCA Foundation to act as an intermediary in the registration of Mauritius until proper regulations are enacted to be properly registered as a confederation.
2. With the registration of the office, the BCA would benefit from the following:
 - i. As a non-profit organisation, BCA will be exempted from Taxes.
 - ii. No duties and taxes for equipment imported by BCA for distribution in Africa.
 - iii. Facilities for work permit and residence permit for staff.
 - iv. Facilities to grant visa on arrival for participants in BCA activities.
 - v. Facilities from the Government for the hosting of Major Events.

Mrs. Zumbrani's dedication and expertise were invaluable, and her commitment to ensuring a smooth handover process to the incoming Treasurer, Mr. Mpiwa Bosenogile, was commendable. We extend our sincere

appreciation to Mrs. Zumbrani for her contributions and wish her well in her future endeavors.

The handover process between Mrs. Chipo and Mr. Mpiwa exemplified seamless continuity and knowledge transfer, ensuring a smooth transition and continuity in financial management practices. Mrs. Chipo's commitment to handholding the incoming team until the completion of the audit reflects her unwavering dedication to the BCA's financial integrity. This collaborative approach ensured continuity and stability within the finance department, allowing for a smooth transition of responsibilities and operations.

In line with our strategic objectives, and our registration as a foundation in Mauritius the BCA embarked on significant initiatives related to financial operations. One such initiative was the transition of our bank account from South

Africa to Mauritius, aligning with our broader organisational goals and regulatory requirements as a foundation in Mauritius. The opening of the new bank account in Mauritius also marks a strategic step towards enhancing financial transparency, efficiency, and regulatory compliance.

Additionally, the hiring of a new Finance and Administration Manager underscored the BCA's commitment to strengthening its financial governance and operational capabilities. Executive Boards' Responsibilities and Approval

The focus of risk management in the BCA is on identifying, assessing, managing and monitoring all known forms of risk across the BCA. While operating risk cannot be fully eliminated, the BCA endeavours to minimise it by ensuring that appropriate infrastructure, controls, systems and ethical behaviour are applied and managed within predetermined procedures and constraints.



Executive Boards' Report

The executive board presents its report for the year ended 31 December 2023.

1. Review of financial results and activities

Main business and operations

The BCA Continental Sport's Governing Body. There were no major changes herein during the year.

The BCA generated a deficit after tax for the year ended 31 December 2023 of USD5,892 (31 December 2022: surplus of USD31,267).

The BCA'S revenue increased from USD10,899 in the prior year to USD166,178 for the year ended 31 December 2023.

The BCA'S cash flows from operating activities changed from an inflow of USD52,184 in the prior year to an outflow of USD84,716 for the year ended 31 December 2023.

2. Going concern

The annual financial statements have been prepared on the basis of accounting policies applicable to a going concern. This basis presumes that funds will be available to finance future operations and that the realisation of assets and settlement of liabilities, contingent obligations and commitments will occur in the ordinary course of business.

The executive board believes that the BCA has adequate financial resources to continue in operation for the foreseeable future and accordingly the annual financial statements have been prepared on a going concern basis.

The executive board is not aware of any new material changes that may adversely impact the BCA. The executive board is also not aware of any material non-compliance with statutory or regulatory requirements or of any pending changes to legislation which may affect the BCA.

The annual financial statements have been prepared on the going concern basis, since the executive board has every reason to believe that the BCA has adequate resources in place to continue in operation for the foreseeable future.

3. Events after reporting date

The executive board is not aware of any matter or circumstance arising since the end of the financial year to the date of this report that could have a material effect on the financial position of the BCA.

Accounting Policies

1. General information

Badminton Confederation Africa is a non-profit organisation.

2. Basis of preparation and summary of significant accounting policies

The financial statements of Badminton Confederation Africa have been prepared in accordance with the International Financial Reporting Standard for Small and Medium-sized Entities and the Companies Act of South Africa. The financial statements have been prepared under the historical cost convention, as modified by the revaluation of investment property, certain property, plant and equipment, biological assets and derivative financial instruments at fair value. They are presented in United States Dollars.

The principal accounting policies applied in the preparation of these annual financial statements are set out below. These policies have been consistently applied to all the years presented, unless otherwise stated.

2.1 Property, plant and equipment

Property, plant and equipment is stated at historical cost less accumulated depreciation and any accumulated impairment losses. Historical cost includes expenditure that is directly attributable to bringing the asset to the location and condition necessary for it to be capable of operating in the manner intended by the executive board.

The BCA adds to the carrying amount of an item of property, plant and equipment the cost of replacing parts of such an item when that cost is incurred if the replacement part is expected to provide incremental future benefits to the BCA. The carrying amount of the replaced part is derecognised. All other repairs and maintenance are charged to surplus or deficit during the period in which they are incurred.

2.2 Financial instruments

Trade and other receivables

Trade receivables are recognised initially at the transaction price. They are subsequently measured at amortised cost using the effective interest method, less provision for impairment. A provision for impairment of trade receivables is established when there is objective evidence that the BCA will not be able to collect all amounts due according to the original terms of the receivables.

Cash and cash equivalents

Cash and cash equivalents includes cash on hand, demand deposits and other short-term highly liquid investments with original maturities of three months or less. Bank overdrafts are shown in current liabilities on the statement of financial position.

Trade and other payables

Trade payables are recognised initially at the transaction price and subsequently measured at amortised cost using the effective interest method.

Accounting Policies

2.3 Inventories

Inventories are stated at the lower of cost and estimated selling price less costs to complete and sell. Cost is determined using the first-in, first-out (FIFO) method. The cost of finished goods and work in progress comprises packaging costs, raw materials, direct labour, other direct costs and related production overheads (based on normal operating capacity). At each reporting date, inventories are assessed for impairment. If inventory is impaired, the carrying amount is reduced to its selling price less costs to complete and sell; the impairment loss is recognised immediately in profit or loss.

2.4 Provisions

Provisions are measured at the present value of the amount expected to be required to settle the obligation using a pre-tax rate that reflects current market assessments of the time value of money and the risks specific to the obligation. The increase in the provision due to passage of time is recognised as interest expense.

2.5 Revenue

Revenue is measured at the fair value of the consideration received or receivable. Revenue is shown net of value-added tax, returns, rebates and discounts.

Interest income is recognised using the effective interest method.

2.6 BWF Grants

Grants from the Badminton World Federation are recognised at their fair value in profit or loss where there is a reasonable assurance that the grant will be received and the BCA has complied with all attached conditions. Grants received where the BCA has yet to comply with all attached conditions are recognised as a liability (and included in deferred income within trade and other payables) and released to income when all attached conditions have been complied with. Badminton World Federation grants received are included in 'other income' in profit or loss.

3. Critical accounting estimates and judgements

Estimates and judgements are continually evaluated and are based on historical experience and other factors, including expectations of future events that are believed to be reasonable under the circumstances.

No significant estimates and adjustments have been applied in the preparation of these financial statements.

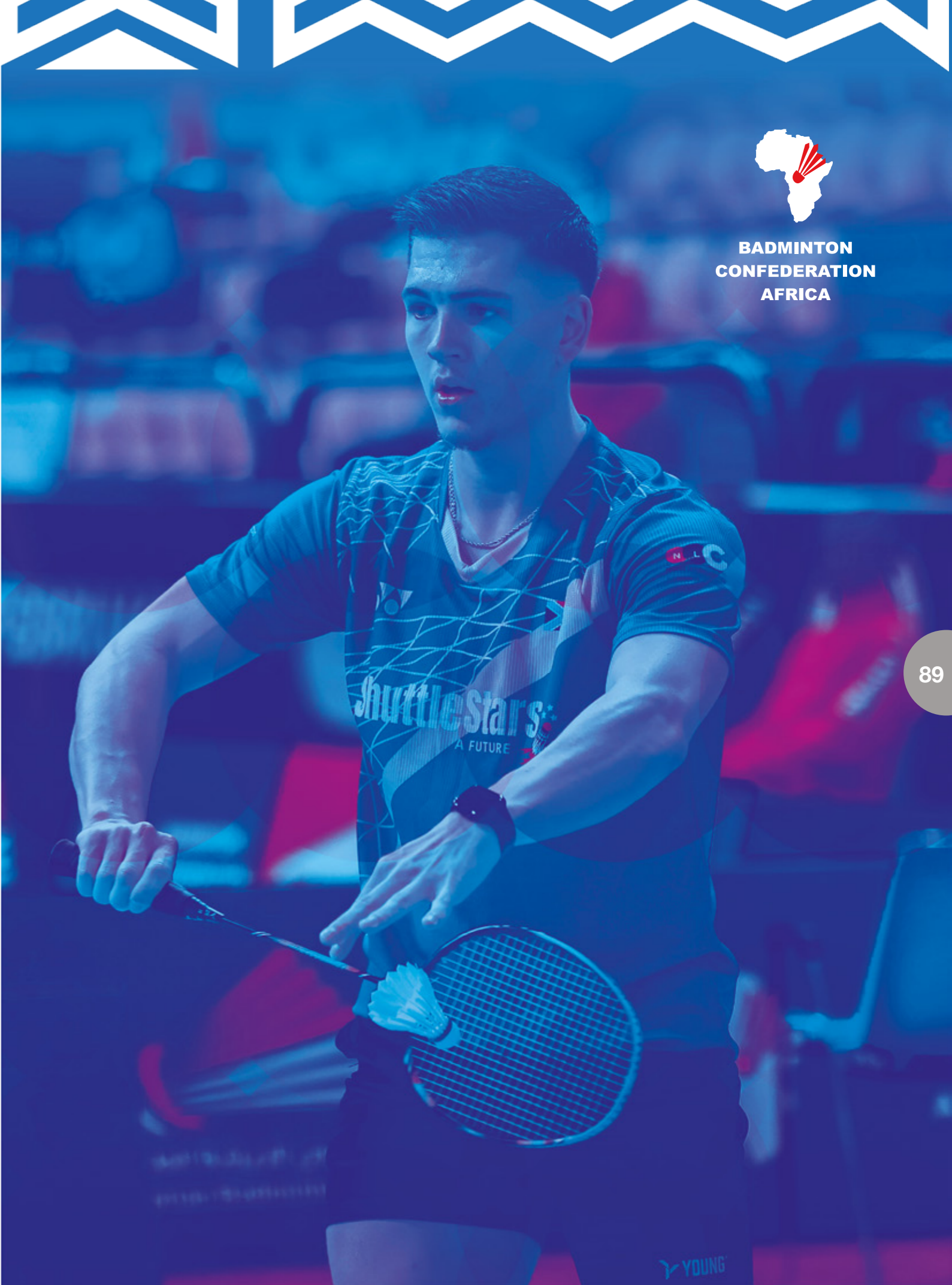
