1 PRELIMINARY BUSINESS

- The CEO outlined the voting procedures as per the BCA Constitution and provided an overview of the housekeeping rules.
- He introduced the use of flash disks containing the minutes of previous meetings.

GENDER EQUITY COMMISSION REPORT

- A video was presented to the members
- The Chair welcomed the members.
- She shared the statistics where female participants rate were highlighted for the development courses organized in our region in 2023.
- The Chair presented the achievements made in 2023:
 - Increase of female participation each year
 - Solutions are implemented to maintain the rate
 - 14% of MA are represented by women
 - 20% of female representation in BCA Council members
 - Initiation of Members Associations women representative group
- The Chair ended by presenting the gold medals won by Mrs. Mariam Eniola Bolaji and Mrs. Shaima Samy

ATHLETES COMMISSION REPORT

- The Chair of the BCA Athletes Commission, Mrs. Deidre Jordaan presented the activity players from the Road to Paris benefited and the tournaments supported in the Olympic race.
- The Chair shared that Para Badminton training camp were organized in Uganda, Spain and for Road to Paris Programme.
- In addition, 8 Juniors players received training scholarships based on their results.

- The Vice-chair presented the key figures concerning social media and more precisely the fan base on Facebook and Instagram.

- The Vice-chair informed members BCA major events were Live Streamed which helped to increase fans and followers.
- He also shared the top 10 countries that are frequenting on our website.
- The Vice chair shared that BCA is still investing in branding the events and activities
- He also shared that host countries of BCA events are receiving the photography grant to support content and visibility
- The Vice-Chair was honored to share that a partnership has been signed with NVBA, an
 international academy in Malaysia to provide advance training and support development with
 programme between NVBA coaches and MAs.
- He also presented the successful sponsors and partners that supported BCA in 2023:

- He ended up sharing that for 2024 the plan and focus will be the same, adding that there will be a BCA Media workshop and investment on BCA photographer.

FINANCE REPORT

The 2023 audit was successfully completed.

Financial highlights:

- Revenue: US\$1,060,183 (BWF grants, sponsorships, and interest income).
- Expenditure: US\$1,044,048.
- Budget deficit of US\$5,892.
- 3.2 Vote 3: Approval of financial statements for 2023 Unanimously approved.

4.0 AUDITORS
