Accreditation	Access to the Tournament venue and other services will be provided through personalised and photographic accreditation.
Clothing and Advertising	Colour, design, lettering and advertising on clothing shall be regulated by BWF General Competition Regulations § 20 to 24. Any breach of these regulations will be forwarded to the BWF. In applying these regulations, the decision of the Referee shall be final.
	Players cannot be entered unless they already have a BWF ID number. In case you wish to enter players, who don't have a BWF ID - number, you can now generate new BWF IDs for your players via Tournament Software.
BWF ID	If you need help to generate new BWF IDs, please contact BWF or BCA (for African Countries) well in advance of the tournament, so that the players concerned can be assigned BWF ID numbers before the closing date of the tournament.
	Doping control in badminton, in accordance with BWF Anti-Doping Regulations, is conducted out-of-competition and in-competition with the collection of urine and/or blood samples.
Doping Control	Athletes are responsible for any substance found in their body. Before an athlete takes any medications, they could check with their doctor, and if necessary, get a Therapeutic Use Exemption (TUE).

Badminton Integrity	To protect the integrity of BWF sanctioned tournaments, participants are not allowed to bet in any way on badminton matches, shall respect the principle of fair play, and shall not attempt to influence the course or result of a game or match.

Conditions	The tournament will be played on knock-out system and in full accordance with the General Competition Regulations of the BWF and the instructions of Badminton Confederation Africa.

	Players shall not plan their departure before the prize giving ceremony; the organisers will not award medals or prize money until <u>ALL</u> finals are over.
	According to the BWF General Competition Regulations, there is no world ranking points for an international tournament with less than 8 entries in (MS, WS, MD, WD, XD). In such a case, the tournament maybe cancelled, and the organisers will not take any responsibility for any arrangements that may have been already made.
